In our area there are few rental buildings large enough to suit our needs. The one we finally acquired is in need of much repair. The landlord will do some of it, but the majority will be done by us in return for a reduced rental rate on a five year agreement. The extension across the back of the building is a post and pole structure, built on loose fill, will small blocks under the posts instead of proper footings. Consequently the whole structure had sunk almost a third of a meter. As well as lifting up and pouring concrete footings, the wells also need vapor barrier, framing, and insulation.

Almost all the costs will be for materials. Club members will do all the structural and electrical upgrades except installation of the roll-up door if that item is included in the project at this time.

Our objective, aside from promoting mental and emotional health in our area is to become a reliable and respected supporter of community service projects and to offer assistance to neighbours in need.

#### **Existing Zoning**

Lot B is currently split zoned Small Holdings (H1) and Large Holdings (H2).


The H1 zoned area is approximately 9.82 ha. in size. The minimum parcel size for the H1 Zone is 2 ha.

The H2 zoned area is approximately 11.5 ha. in size. The minimum parcel size for the Large Holdings zone is 8 ha.




### **Denied Zoning**

The applicant proposed to rezone all of Lot B to Small Holdings to accommodate an eight lot subdivision. This application was denied by the Regional District Board at its August 18, 2016 meeting.



#### **Proposed Zoning**


The current application proposes to swap the Small Holding's zone with the Large Holdings zone to allow a six lot subdivision. The northern portion of the property, currently zoned Large Holdings (H2) will become Small Holdings (H1) to create five 2.0 ha. lots. The southern portion of the property is proposed to be changed from Small Holdings (H1) to Large Holdings (H2) to accommodate a 9.82 ha. lot.



## **Existing Subdivision Potential**

The current zoning on Lot B would potentially allow the land to be subdivided into 6 lots in total. However, the area that is currently zoned H1, and has subdivision potential is quite swampy. The area that is currently zoned H2 is more suited for subdivision, and is more easily accessed by Yelich Road.

The previously proposed subdivision Plan, which was denied, is shown below on the right. The subdivision plan proposed with the current rezoning application is shown below on the left.



## PLANNING DEPARTMENT COMMENTS

The public hearing for Bylaws 1786 and 1787 was held on May 8<sup>th</sup>, 2017. No concerns or comments were raised.

At the Regional District of Bulkley-Nechako May 25, 2017 Board meeting Third Reading was given to "Smithers Telkwa Rural Official Community Plan Amendment Bylaw No. 1786, 2016" and "Regional District of Bulkley-Nechako Rezoning Bylaw No. 1787, 2016." In addition, the Board moved "that Final Reading not be considered until the Section 219 Covenant is registered on the title of the subject property, Lot B, Section 14, Township 1A, Range 5, Coast District, Plan EPP25548, Except Plan EPP42101."

The Section 219 Covenant (Charge No. CA6122992) has been registered on Lot B's property title and the covenant is attached to this report.

The rezoning bylaw has been signed by the Ministry of Transportation and Infrastructure, as required. This OCP amendment and rezoning bylaw are therefore brought forward for consideration of adoption.

#### **Recommendations:**

That "Smithers Telkwa Rural Official Community Plan Amendment Bylaw No. 1786, 2016" and "Regional District of Bulkley-Nechako Rezoning Bylaw No. 1787, 2016" be adopted.







(together the "Airport Lands")

- C. The Transferee and its related predecessors in title and its and their servants, agents, contractors, licensees and related corporations have, over a substantial period of years, developed and conducted, now conduct and/or will hereafter continue to conduct on the Airport Lands or portion or portions thereof, existing and future industrial land uses, including but not limited to:
  - (a) the Smithers Regional Airport; and
  - (b) other industrial operations including but not limited to: airport operations, terminal and aviation related uses, air cargo and runway maintenance 24 hours per day, seven days a week, airport construction, airport equipment maintenance, manufacturing, land clearing, building construction, industrial park, fuel storage, dispensing & sales, automobile rental, trucking & freight depot, laboratory, testing facility, outdoor storage, warehousing, wholesaling, camp & expediting services

(together the "Industrial Uses");



- D. The Transferor wishes to obtain approval from the Regional District of Bulkley Nechako for amendments to the official community plan designation and zoning of the Property to facilitate subdivision permitting additional residential dwellings, and recognizing that it is in the public interest that future property owners of said lands be aware of the neighbouring Industrial Uses and that such Industrial Uses are permissible despite nuisances created, wishes to grant this Easement to the Transferee;

  - (b) any odour, dust, or litter emanating from the Airport Lands to the Property; or
  - (c) noxious gases, smoke, dust, loud noises, excessive light, or high temperatures emanating from the Airport Lands to the Property.

## 219 COVENANT

- 2. The Transferor covenants and agrees with the Transferee, pursuant to Section 219 of the Land Title Act that:
  - the Property shall only be used in compliance with Section 1 of this Agreement and with due regard for the potential impact of any Industrial Uses on the Property;
  - (b) the Transferor shall ensure, at all times, that any portion of the Property within 7.5 m of the Airport Lands shall not be built upon in any manner, whatsoever; and

(c) the Transferor shall maintain, in perpetuity, the existing 7.5m treed buffer on any portion of the Property adjacent to the Airport Lands.

### INDEMNITY AND RELEASE

- 3. The Transferor covenants and agrees:
  - (a) To save harmless and indemnify the Transferee, its officers, invitees, licensees, employees, servants and agents from and against all actions, causes of action, losses, damages, costs, claims, debts, injurious affection, and demands whatsoever and by any person, whether known or unknown, which has arisen or may arise out of or in any way due directly or indirectly to the granting or existence of this Agreement including:
    - i. any impact on the use of or value of the Property arising from the Industrial Uses or breach of any covenant or agreement on the part of the Transferor contained in this Agreement; and
    - ii. the granting of the easement or this Covenant.

# Emergency Preparedness Planning Workshop - Summary Report

Nechako Reservoir Dam Emergency Plan

**REVISED DRAFT July 12, 2017**

#### 1. Overview

Rio Tinto held a workshop in Vanderhoof, BC, on June 20, 2017, to share information about the Emergency Preparedness Planning (EPP) Program related to the Nechako Reservoir Dam Emergency Plan (DEP), with a focus on communicating the nature of potential water related risks, gathering feedback on plans and communication protocols, and identifying next steps to facilitate response plan development from targeted stakeholders, and First Nations.

Notification of the workshop was distributed by email to select individuals belonging to government, and local community and First Nations. A list of represented stakeholders and First Nations is provided in section 4 below.

The workshop emphasized active participation of attendees through group discussion. The workshop was well attended and spurred a good level of participation by attendees in regards to feedback and constructive discussion.

The following topics were identified by participants as key areas of interest for discussion:

- Emergency Event Notification Procedures: Event notification was of utmost importance to those in attendance. Several participants raised concerns regarding the speed of notification, the means of notification, and those identified and/or omitted on the notification list.
- Clarification of Roles & Responsibilities: Participants demonstrated a lack of clarity of roles and responsibilities across all facets of emergency planning and response during an emergency event. The group agreed that improved understanding and alignment needs to be clarified amongst Rio Tinto, local communities and First Nations, and government at each step in emergency preparedness planning.
- Water Management: The subject of water management was raised by participants several times during the workshop. It is considered to be a foundational issue to be addressed as a key element in emergency preparedness and response. Rio Tinto identified this as a very important but somewhat distinct topic. Participants welcomed the suggestion that Rio Tinto could address this issue through an engagement process.

#### 2. Purpose

The purpose of this workshop was to provide information to and receive feedback from a targeted audience regarding Rio Tinto's EPP Program related to the Nechako Reservoir DEP. The workshop focused on obtaining recommendations from the community with respect to improving Rio Tinto's DEP.

#### 3. Workshop Format

Rio Tinto hosted the workshop at the Vanderhoof Fire Hall. The workshop was held from 9:00 a.m. to 4:00 p.m., and food and refreshments were provided. Attendees were greeted by Rio Tinto representatives, asked to sign-in and were provided a draft DEP for collecting feedback. A series of presentations were delivered by government and Rio Tinto representatives, with time for questions throughout to facilitate discussion. These were then followed by breakout sessions. A third party acted as facilitator and meeting recorder during the workshop. Rio Tinto representatives were in attendance to present and observe with the opportunity to interact with attendees during breakout discussion, breaks and following the conclusion of the workshop. This format was intended to provide participants with a space to openly share comments and recommendations with facilitators and subject matter experts.

#### 4. Participation

Participants were requested to sign in as they arrived. Attendance at the workshop was:

15 attendees

The workshop was intended for community stakeholders and First Nations; invitees were encouraged to invite other emergency planning team members they believed the workshop would be of interest to. Individuals in attendance represented the following organizations and First Nations:

- Ministry of Forests, Lands and Natural Resource Operations
  - Northwest Emergency Management BC (NEMBC)
  - o Dam Safety
  - o Flood Hazard
  - o Special Projects
- Cheslatta First Nation
- Nee Tahi Buhn First Nation
- Skin Tyee First Nation
- Village of Fraser Lake
- District of Vanderhoof
- Regional District of Bulkley-Nechako
- District of Vanderhoof

In addition, two representatives from Rio Tinto and a two-member facilitation team were present.

#### 5. Workshop Methodology

The following methods were implemented to facilitate the sharing of information, discussion, and solicitation of feedback.

5.1 Presentation: The workshop involved a presentation given by government representatives on dam safety regulations and Emergency Management BC programs and services, and by Rio Tinto representatives on Rio Tinto BC Works and emergency preparedness. Participants were encouraged to ask questions at any time during the presentation.

5.2 Breakout Sessions: The workshop incorporated breakout sessions to encourage participation by attendees and feedback. Participants were asked to discuss and report back to the plenary on four key topics (Flood Impact Risk & Documentation, Event Notification Procedures, Information Management During Event, and Community & Public Awareness).

5.3 Feedback Notes: Participants were provided copies of the Draft Nechako Reservoir DEP to review and mark-up with feedback notes.

#### 6. Notification

Notification of the workshop was provided by email to targeted individuals, with an opportunity to extend the invitation to other interested parties as they deemed appropriate.

#### 7. Feedback Results

Feedback from participants was gathered through breakout discussions and feedback notes. Feedback is summarized below in two parts – Section 7.1 provides a key theme summary of comments and questions through conversations, and further information regarding input received through feedback notes can be found in Section 7.2. Appendix A presents specific questions raised during the workshop.

7.1 Workshop Key Themes: The following key theme summary reflects feedback received through conversations between Rio Tinto representatives and facilitators, and attendees during the workshop.

The following represents an overview of key concerns and interests identified across the series of working sessions:

#### Event Notification Procedures:

- Speed/Efficiency & Means of Emergency Notification: Several participants raised concerns about the "outdated" methods currently used, and many suggested alternate options. Consensus of the group was that multiple channels (radio, TV, and social media, in addition to phone and fax) should be incorporated at a minimum. If possible, flood-specific systems were suggested similar to various notification systems already in place (Amber Alert, Tsunami sirens, BC One Call, etc.). Maximum efficiency and maximum reach emerged as key areas of concern with respect to notification procedures.
- Contact List: The need for a broader understanding of who was included on the contact list and why, and how this list aligns or overlaps with other stakeholders or First Nations notification procedures emerged as a point of discussion. Some suggestions were made as to who may need to be added to the list, and queries were made into how this list may trigger other notification procedures.

#### • Clarification of Roles & Responsibilities:

o General discussion around flood scenarios often revolved around whose role or responsibility it was to engage or activate various steps of each plan. There appeared to be considerable confusion at points where there may be overlap in responsibility among the various levels of government, local and First Nations first responders, and Rio Tinto as the dam owner. Additionally, there appeared to be a lack of clarity, or definition between the role of an EPP versus the role of an Emergency Response Plan (ERP) and the parties responsible for developing each. NEMBC's role in particular was a topic of much discussion – many of their responsibilities were not known by participants, or simply not identified in the DEP.

#### 7.2 Feedback Note Results:

In addition to the open discussion, feedback was also captured through feedback notes directly attached to copies of the Draft Nechako Reservoir DEP provided to participants during the workshop. At the conclusion of the workshop, the Draft Nechako Reservoir DEP binders and related feedback notes were gathered by Rio Tinto to be reviewed and aggregated, and then incorporated into the next DEP.

#### 7.3 Recommendations from Workshop Participants

Recommendations were positive and participants were eager to be engaged and to continue to receive further information from Rio Tinto related to the EPP Program and the Nechako Reservoir DEP.

# The following presents recommendations provided by participants to improve Rio Tinto's EPP with respect to the Nechako Reservoir DEP.

#### Action Required

The following action / follow up is required based on conversations and feedback received at the workshop and feedback forms.

- 1. Distribute presentations to attendees.
- 2. Rio Tinto to follow up on recommendation to include Aboriginal Affairs and Northern Development on the notification list in the Nechako Reservoir DEP.
- 3. Ensure the Nechako Reservoir DEP is written in active tense, rather than passive tense (example was Section 2.1) to ensure clarity of actions required by the person reading the plan.
- 4. Rio Tinto to ensure 911 is aware of, and has a copy of the Nechako Reservoir DEP in the event they receive a call regarding a dam breach.
- 5. Regarding the Notification Chart, there should be a service similar to BC One Call to assist in notifying all impacted parties, rather than one individual making every phone call, one at a time.
- 6. Reaching out to individual authorities should be coordinated at a higher level than at the local level.
- 7. There is a need for a separate, parallel individual citizen plan with accompanying public outreach to address evacuation concerns not covered in the Nechako Reservoir DEP.
- 8. There is a need for an updated, instantaneous alert system similar to Amber Alert in the event of an emergency FM radio, Satellite TV, web and other updated means of notification should be deployed.
- 9. Northwest Emergency Management BC's (NEMBC) coordination calls during an event should be identified in Rio Tinto's EPP.
- 10. Coordinate sand bag deployment process with NEMBC Rio Tinto should provide statistics supporting probability of flood risk to expedite task number process when conditions do not meet NEMBC's thresholds (2015 flood was raised as an example).
- 11. Inundation maps requested for additional scenarios (i.e. 1 in 200 year flood).
- 12. Water level graphs should include baseline elevation markers for local communities so the increase in water elevation is clear.
- 13. Develop a "cheat sheet" or one-pager which conveys impacts based on various levels of flow. Use photographs from previous flood events to provide visual aids.
- 14. More coordination between Rio Tinto and River Forecast during predictable events is needed (ie. freshet).
- 15. Notification Chart should include information about what calls will be made by NEMBC and other stakeholders, as well as a means of confirmation that calls were in fact made.
- 16. Rio Tinto should have a public-facing call centre or Facebook page to activate during an event.
- 17. Step changes in response requirements should be identified during various stages of a flood (ie. when there may be impacts to sewer systems, critical infrastructure, etc.).
- 18. Rio Tinto, in coordination with NEMBC to follow up on whether there is viability in building a sandbag storage warehouse, and if so, identify areas of possible grants/funding.
- 19. Rio Tinto committed to a 2-step process at the outcome of the workshop: 1) incorporate workshop feedback into the next Draft Nechako Reservoir DEP version and provide back to the participants for final feedback; and 2) Incorporate all additional feedback to finalize, and distribute the Nechako Reservoir DEP.

#### APPENDIX A Overview of Questions

The following provides a detailed list of questions raised during the working sessions:

- 1. How long would a dam last if built correctly?
- 2. What is the maximum discharge of spillway allowed?
- 3. When reservoir is near capacity, can you explain the 14 to 1 ratio during periods of significant moisture?
- 4. If you had a failure in power lines at the smelter, why can't you keep operations running by generators?
- 5. What are the chances of all dams failing at the same time?
- 6. Can we look at the dams on a computer?
- 7. Wouldn't it be best to notify people of an emergency event by computer?
- 8. How do you notify contractors (ie. loggers) of emergency events?
- 9. Who do you notify first if you see a leak at a dam?
- 10. Could Rio Tinto install cameras at their dams?

- 12. Regarding the Notification Chart: Is one person making all 8 calls?
- 13. If responsible for making the notification call, what information needs to be conveyed? Is there a script?
- 14. If there is a breach, how long does it take to evacuate Vanderhoof?
- 15. If evacuating, where does Vanderhoof evacuate to?
- 16. In an emergency situation, how are individuals notified? There are sirens for tsunamis, what is there for flood warnings?
- 17. Is there a reason some First Nations are not included in the notification list?
- 18. Regarding communications updates during an event: Have you used social media? You should coordinate with local community and First Nations Facebook pages.
- 19. Does Rio Tinto update their website during an event?
- 20. At what flood elevation is there potential impacts to the Fort Fraser sewer system?
