#### **BUSINESS ARISING**

# Coastal GasLink Timber Salvage Strategy

Chair MacDougall mentioned that the Coastal GasLink Timber Salvage Strategy and that it could be used as a template for other pipeline projects. He spoke of Directors visiting sawmills and processing plants in their electoral areas to determine whether Coastal GasLink has approached them in regard to processing the volume of fibre from right of way clearing.

Discussion took place regarding other pipeline companies and whether or not they may have approached the processing facilities regarding the use of fibre from their rights of way.

## Discussion with Albert Nussbaum

Director Miller commented that he met with Albert Nussbaum, Director, Forest Analysis and Inventory Branch in Burns Lake recently. Mr. Nussbaum reported that the partition went into major forest stands to mitigate the mountain pine beetle. There is a major change to the landscape. He mentioned there will be pressure to keep in place the cut level. Cutting will become much more precise and surgical in the removal of timber to make sure the undergrowth is not impacted.

Director Miller spoke of the incredible importance of the fibre cleared for pipelines being utilized to influence the huge negative impact to the midterm timber supply.

#### Invasive Plant Management

Discussion took place regarding pipeline projects response to invasive plant management along rights of way. Jason Llewellyn, Director of Planning mentioned that during the Environmental Assessment Review Process the RDBN requested that the RDBN be able to review and provide comment in regard to the invasive plant management plan. Coastal GasLink indicated they would provide their invasive plant management plan for review but that has not yet happened. The RDBN also requested that a program be implemented similar to the financial partnership between other right of way owners such as Ministry of Transportation and Infrastructure.

#### CARRIED UNANIMOUSLY

Discussion took place regarding the actions that could be undertaken by participating organizations to improve wildfire management in the region. Staff will bring forward a report to outline what initiatives are currently being undertaken by the RDBN. The RDBN Board can review the report and determine what more it would like to do in regard to wildfire management.

Concerns were brought forward that funding for the Omineca Beetle Action Coalition may not continue beyond March, 2016 but yet the communities impacted by the mountain pine beetle are just beginning to feel the impacts.

Discussion took place regarding the OBAC Pine Beetle Investment Account and the possibility to access funding for wildfire management initiatives.

Advocacy on behalf of the Regional Board and Forestry Committee was brought forward for discussion. The mountain pine beetle has also created more intense wildfires that cause more damage to the landscape than wildfires that go through green stands of fibre.

Discussion took place regarding the utilization of slash piles and burning slash piles. Director Brienen will follow-up with the sawmill and processing plant in Houston in regard to the slash piles in the area. The challenges of utilizing wood in slash piles was discussed.

Director Miller spoke of legislation that is drafted regarding the utilization of waste wood.

Director Liversidge mentioned that Josh Pressey, Ministry of Forests, Lands and Natural Resource Operations will be meeting with the Village of Granisle in November, 2015 to try to find options in regard to wildfire mitigation.

Chair MacDougall asked staff to respond to the correspondence from Babine Lake Community Forest Society dated October 16, 2015 and outline that a future workshop will include the topic of removing a wildfire management buffer zone from communities that can be utilized through different economic opportunities.

Dear Woods Managers:

Due to some recent issues that have arisen and resulted in conflicts between forest sector development activities and the operations of trapline tenure holders, I am sending this letter to reiterate the importance of forest licensee led communication with other licensed users of crown lands within your areas of operations.

Through discussions on these matters I have been informed that issues most frequently arise from changes to access infrastructure including new road building, brushing or reactivation of existing road infrastructure, changes to maintenance of winter access (snow ploughing), and from harvesting activities. I am confident that early and effective communication between forest tenure holders and the trapping and guiding community can resolve these issues before they arise.

Accordingly, it is my expectation that the following practices will be employed. Forest Licensees will share maps and engage with active trappers and guide outfitters on their planned annual activities well prior to the beginning of the trapping and hunting season and at the latest by September 1. Maps should show planned haul routes and development that is expected to be active and communications should identify updated Licensee contact information to allow for in-person follow up meetings to discuss any conflicts with the planned guiding or trapping operations. Licensees should also be providing their updated areas of operation to allow for improved on-going communication between the forest sector, trappers, and the guiding community.

I will be checking back with all parties on the effectiveness of communication efforts, and will follow up where on-going issues persist. I will also be considering the effectiveness of the communication processes being employed at the time of Licensee Forest Stewardship Plan replacement or extension.

Finally, because of specific concerns brought forward with regard to individual traps or trapping sites being targeted and disturbed, I am requesting that you remind your woods staff

and contractors that any such deliberate practices involving the damage or interference with lawfully set traps are considered to be an offence under the Wildlife Act.
