#### **NEW BUSINESS**

FCM Update - Director Miller

Director Miller mentioned that he attended the Federation of Canadian Municipalities (FCM) Convention in Ottawa, Ontario June 1-4, 2017. While at FCM he attended the Rural Broadband Forum. There were four panelists, three telecommunications companies and a financial analyst that has completed business case research for the major equity banks. They discussed the need for backbone as various technologies improve rapidly. The \$500 million of federal funding will be utilized very quickly and more funding will be required in order to provide adequate service to rural communities. The majority of the panelists also expressed the need for the funding to be competitively neutral with no competitive advantage for one carrier over another.

Director Newell noted that the backbone in the region runs along Highway 16 only. He also spoke of his download and upload speeds utilizing Explornet and that the cost may not be prohibitive for all users.

SUBJECT: Mail Ballot Voting

The RDBN has received several requests from Electoral Area "F" (Vanderhoof Rural) residents to consider reviewing its Mail Ballot Voting Bylaw to offer mail ballot voting throughout the region for both elections and referenda. Currently, the bylaw allows mail ballot voting in the Cluculz Lake Fire Protection area for referenda only (see attached bylaw). The bylaw was adopted as a "pilot" in 2011 and included the specified area as a result of numerous requests from "seasonal dwellers."

The sequence of events following up to and after the adoption of the mail ballot bylaw is as follows:

- November 6, 2010 Referendum was conducted for Cluculz Lake Rural Fire Protection Service Establishment Bylaw No. 1565, 2010.
  - Referendum Failed area "F" residents conveyed that the process was unfair as many seasonal dwellers were not provided adequate opportunity to vote (ie lack of mail ballot voting).
- May 24, 2011 staff prepared report for RDBN Board regarding Mail Ballot Voting. (Schedule "A")
- June 23, 2011 RDBN Board passed a resolution to amend the Election Procedure Bylaw to allow for mail ballot voting for <u>referenda only</u> in the Cluculz Lake Area (boundaries of Cluculz Lake Fire Protection Area). The decision was not unanimous. (Schedule "B")
- February 16, 2013 Referendum was conducted for Electoral Area "F" (Vanderhoof Rural) Vanderhoof Swimming Pool Contribution Service Establishment Bylaw No. 1644
  - First Opportunity for Mail Ballot Voting 181 ballots requested –
     162 were returned in time.
  - Referendum Failed Area "F" residents expressed concern that mail ballot voting was not allowed for <u>all</u> Area "F" residents (only residents in Cluculz Lake Fire Protection Area as per bylaw 1617).
- November 2014 Elections were conducted.

- o Received feedback from residents of Area "F" that mail ballot voting should be allowed for both elections and referenda.
- October 6, 2015 Request from Reta Herrick, resident of Cluculz Lake, to appear as delegation re: Mail Ballot Voting (petition was presented to allow mail ballot voting region wide for elections and referenda). (Schedule "C")
- October 22, 2015 Reta Herrick, Randy Holubosh, and Percy Wright appeared as a delegation to the RDBN Board of Directors (presented petition with 438 signatures). (Schedule "D")
- RDBN Board of Directors requested staff to prepare a cost analysis report regarding mail ballot voting. The costs are an estimate only as it is difficult to predict the demand for each area. Postage costs have increased since the cost analysis was prepared. (Schedule "D")
- March 8, 2016 Staff emailed Reta Herrick and advised that the report would be included in the March 10, 2016 Committee of the Whole Agenda (Schedule "E")
- March 10, 2016 Staff report presented to Committee of the Whole
  - Board requested information regarding the UBCM decision regarding Internet Voting. (Schedule "F")
- June 28, 2016 Reta Herrick emailed staff indicating that she could not locate any action that was taken in regard to Bylaw No. 1617. (Schedule "G")
- Staff responded to Reta Herrick and advised that the report was received and that no further action was taken. The meeting minutes were attached for her reference. (Schedule "H")
- November 7, 2016 Reta Herrick emailed the RDBN requesting an update. (Schedule "I")
- At that time, staff discussed the issue with Chair Miller and Director Petersen. Direction was given to staff to compile the chain of events for discussion at a future date.
- May 20, 2017 Reta Herrick emailed the RDBN requesting an update. (Schedule "J")

Staff have researched the UBCM resolution database in regard to online voting. Only 2 resolutions were found – one was not admitted for debate and the other was removed from consideration. (Schedule "K")

In 2003, the City of Coquitlam submitted a resolution to UBCM to broaden the use of mail-in voting for Local General Elections. The resolution was endorsed at the convention. The Ministry of Community, Aboriginal and Women's Services responded that they had previously sent out a questionnaire to local government election officers to gather information regarding mail-in ballot voting. At that time twenty local governments supported mail ballot voting while 53 did not. Sufficient concerns were expressed about the additional administrative burden imposed on smaller local governments. (Schedule "L")

Following an Elections BC report titled "Discussion Paper: Internet Voting" an Independent Panel on Internet Voting was tasked with reviewing the

opportunities and challenges related to the potential implementation of Internetbased voting for provincial or local government elections in British Columbia. (Schedule "M") (Under Separate Cover)

The following recommendations arose out of a report from the Independent Panel on Internet Voting to the Legislative Assembly of B.C.: (Schedule "N") (Under Separate Cover)

- Do not implement universal Internet voting for either local government or provincial government elections at this time. However if internet voting is implemented, it should be limited to those with specific accessibility challenges. If Internet voting is implemented on a limited basis, jurisdictions need to recognize that the risks to the accuracy of the voting results remain substantial.
- 2. Take a province-wide coordinated approach to Internet voting.
- Establish an independent technical committee to evaluate Internet voting systems and support jurisdictions that wish to implement approved systems.
- 4. Evaluate any Internet voting system against the principles established by the panel.

It does not appear that the province intends to implement on-line voting in the near future.

It is important to note that under the *Local Government Act*, offering mail ballot voting is not a requirement of Local Government - it is at the discretion of the local government. Section 110 of the *Local Government Act* outlining the provisions for mail ballot voting is attached. (Schedule "O")

Each year, the RDBN contributes money toward its election reserve. This is a rural government expense. Referenda are initially included under Feasibility Studies – this is a general government expense. If the referendum is successful, the cost of the referendum is applied to the service established. If the referendum fails, it is a general government expense paid for by all taxpayers in the region.

In summary, the RDBN currently offers mail ballot voting for referenda only for a portion of Electoral Area "F" known as the Cluculz Lake Fire Protection Area. Some Electoral Area "F" residents have requested that consideration be given to amending "Regional District of Bulkley-Nechako Mail Ballot Authorization and Procedure Bylaw No. 1617, 2011." As outlined in Schedule "D", mail ballot voting requires additional resources and an increase in the budget.

Outlined below are a number of options to be considered in regard to mail ballot voting in the RDBN. At this time, staff is seeking Board Direction by way of a resolution.

# Option 1

That the "Regional District of Bulkley-Nechako Mail Ballot Authorization and Procedure Bylaw No. 1617, 2011" remain status quo.

# Option 2

That Bylaw No. 1617 be amended to allow mail ballot voting for all of Electoral Area "F" for referenda only.

# Option 3

That Bylaw No. 1617 be amended to allow mail ballot voting for all of Electoral Area "F" for both referenda and elections.

#### Option 4

That a new mail ballot authorization bylaw be drafted that includes mail ballot voting for the entire region for referenda only.

# Option 5

That a new mail ballot authorization bylaw be drafted that includes mail ballot voting for the entire region for both referenda and elections.

# Option 6

That Bylaw No. 1617 be rescinded.

SUBJECT: Mail Ballot Voting

Staff have currently been researching mail ballot voting and have contacted other Regional Districts to determine if they conduct mail ballot voting. Out of 28 Regional Districts, 13 conduct mail ballot voting. Following are some comments received from Regional Districts:

- The Alberni Clayoquot Regional District introduced mail ballot voting in 2008 and are reconsidering for 2011 due to the amount of work involved.
- The Fraser Fort George Regional District conducts mail ballot voting for elections only. For the last election, they sent out 7 mail ballot packages and received 1 back.
- The Cariboo Regional District has indicated that the timeframe is too short to conduct mail ballot voting for elections, however, it works well for referenda.
- The Central Coast Regional District limits mail ballot voting to 2 electoral areas only.
- The Cowichan Valley Regional District has received less than 10 requests from electors for mail ballots over the last 5 general local elections/referenda.
- The Strathcona Regional District has indicated that it is a lot of work for the number of ballots actually received.
- The Sunshine Coast limits mail ballot voting to Passage and Bowver Island residents only.

The typical process for conducting mail ballot voting is as follows:

- Advertisement is placed indicating mail balloting information. 1.
- 2. A time period is established for accepting applications for mail ballot packages.
- 3. Upon receipt of a valid application for a mail ballot, the Chief Election Officer sends to the applicant a mail ballot package together with an application for registration as an elector.

- 4. The Chief Election Officer records the name and address of the person to whom the mail ballot package has been sent.
- 5. Upon receipt of a mail ballot package, the Chief Election Officer shall record the date of such receipt and remove and examine the certification envelope and the completed elector registration application and mark the certification envelope as "ACCEPTED" or "REJECTED."
- 6. Certification envelopes remain unopened until such time as determined by the Chief Election Officer.

I have attached Section 100 of the *Local Government Act* pertaining to mail ballot voting.

Advertising costs would increase as 2 additional newspaper ads would be required for each election/referendum. The information would also be posted on the RD website for property owners that may not see the newspapers.

One of the challenges with mail ballot voting is the tight timeline that exists, especially for elections. For an election, ballots cannot be ordered until after 4:00 p.m. on Friday, October 28<sup>th</sup> which is the deadline for withdrawal of candidates. Typically it takes the printer a minimum of 1 week to have the ballots printed. If the ballots were printed by November 7<sup>th</sup>, there would be approximately 2 weeks for the Regional District to send the mail ballot package out <u>and</u> get it back prior to the close of voting on general voting day.

To date, the biggest demand for mail ballot voting was during the "Cluculz Lake Rural Fire Protection" referendum. Many "seasonal" dwellers were not able to vote at either the advance poll or on general voting day.

The Local Government Act states that there is an obligation of the elector to ensure the delivery of the mail ballot to the Chief Election Officer before the close of voting on general voting day. Should mail ballot voting be established in this area, a polling station would also be required at the Regional District of Bulkley-Nechako office to accommodate any mail ballots that may be delivered on general voting day.

Taking into consideration the comments from other Regional Districts, staff is recommending that the RDBN Election Procedure Bylaw be amended to allow for mail ballot voting for referenda only in the Cluculz Lake Area. This would give staff the opportunity to become familiar with mail ballot voting and to weigh the pros and cons of implementing mail ballot voting region-wide in the future.

# A Petition to Amend Bylaw 1617, 2011 to allow Mail In Ballots during all RDBN elections

# WHEREAS the Local Government Act permits voting by mail in ballot;

And WHEREAS poor voter turnout at all levels of government is a concern across Canada and the remote location of rural areas like Cluculz Lake and Bobtail Lake discourages voter turnout;

And WHEREAS Section 100 (3)b of the Local Government Act allows for mail in ballots for regional districts if the area is "remote from the voting places at which persons who reside in the specified area are entitled to vote" and Section 100 (3)c contemplates "persons who expect to be absent from the regional district on general voting day and at the times of all advance voting opportunities"

And WHEREAS voter turnout has decreased a staggering 62% in Area F since the pool referendum (the February 2013 pool referendum vote: Area F 1047 (with mail in ballots); the 2014 election: Area F 401 (in person only);

THEREFORE we, the undersigned, respectfully request the Board of Directors of the Regional District of Bulkley Nechako amend Section 2.1 of *Regional District of Bulkley-Nechako Mail Ballot Authorization and Procedure Bylaw No. 1617, 2011* which "limits mail in ballots for referenda only" to include referenda, general local elections and by-elections.

# WHEREAS the Local Government Act permits voting by mail in ballot;

And WHEREAS poor voter turnout at all levels of government is a concern across Canada and the remote location of rural areas like Cluculz Lake and Bobtail Lake discourages voter turnout;

And WHEREAS Section 100 (3)b of the Local Government Act allows for mail in ballots for regional districts if the area is "remote from the voting places at which persons who reside in the specified area are entitled to vote" and Section 100 (3)c contemplates "persons who expect to be absent from the regional district on general voting day and at the times of all advance voting opportunities"

And WHEREAS voter turnout has decreased a staggering 62% in Area F since the pool referendum (the February 2013 pool referendum vote: Area F 1047 (with mail in ballots); the 2014 election Area F 401 (in person only);

THEREFORE we the undersigned, respectfully request the Board of Directors of the Regional District of Bulkley Nechako amend Section 2.1 of Regional District of Bulkley-Nechako Mail Ballot Authorization and Procedure Bylaw No. 1617, 2011 which "limits mail in ballots for referenda only" to include referenda, general local elections and by-elections.

# RETA HERRICK & RANDY HOLUBOSH - Re: Mail Ballot Voting in Electoral Area "F" (Vanderhoof Rural)

Chair Miller welcomed Reta Herrick & Randy Holubosh, residents of Cluculz Lake.

Mrs. Herrick thanked the Regional Board for the opportunity to present the petition of 438 signatures.

The residents and property owners at Bobtail and Cluculz Lakes are respectfully requesting that the Board of Directors of the Regional District of Bulkley-Nechako amend Section 2.1 of Bylaw 1617, 2011 to include referenda, general local elections and by-elections for Bobtail and Cluculz Lakes.

The voting stations are at Cluculz Lake and Vanderhoof. The remote distance to travel in the fall when roads are often hazardous, makes it difficult if not impossible for voters to exercise their democratic right to vote. Being a recreational area, many property owners live in and around the Prince George Area. Several non-resident property owners live as far away as Vancouver Island, Prince Rupert and Fort St. John; others are snowbirds or workers in remote camps. Mail-in ballots would give them all a voice.

Statistics for previous ballot counts at the Cluculz Lake voting station with no mail-in voting:

- November 2010 Cluculz Lake Volunteer Fire Department referendum vote, 208 votes were cast:
- November, 2014 election of Directors for RDBN 168 votes were cast.
- February, 2013 Pool Referendum vote:
  - o Mail-in was permitted for Cluculz Lake, not Bobtail Lake;
    - Total of 296 votes cast locally:
      - 150 votes cast at the Cluculz Lake voting station;
      - 145 mail-in votes. (one rejected)

These statistics show mail-in ballots certainly do encourage voter participation.

A survey of other Regional Districts in British Columbia showed that most districts have a bylaw to allow mail-in voting for all elections. This includes the District of Fraser-Fort George. Their area includes Cluculz Lake neighbours to the east of Bednesti, Dahl and Norman Lakes.

Please help to encourage voter turnout by amending this bylaw to permit all residents and non-resident property owners the opportunity to vote.

Mrs. Herrick thanked the Regional Board for the opportunity to present the petition.

Mr. Holubosh thanked the Regional Board for the opportunity to speak in regard to the need to correct the injustice to a group of overlooked people. Seasonal and fulltime taxpayers are not able to vote in RD elections along with disabled and seniors that have had to move to larger communities as their health no longer allows them to live at the lake. They lose the ability to vote without mail in ballots. Mr. Holubosh mentioned that he felt the democratic rights of individuals is violated without the ability to have mail in ballots and this is not the way to be treated as an aging population.

Seasonal property owners that live in Prince George and other communities also have challenges voting during an election as they also need to vote in the area in which they live and in order to leave after work, travel to the Cluculz Lake polling station is difficult as road conditions can be a factor. Mr. Holubosh noted that there is no control in regard to the road conditions but the ability to vote can be resolved with a mail in ballot system to improve the democratic process.



Mr. Holubosh commented that this is Canada and the Regional Board has the ability to change this process.

There are 438 signatures on the petition from property owners of Cluculz Lake and Bobtail Lake and not just random people. These vested interest taxpayers which exceeds the total people that voted in the Electoral Area "F" (Vanderhoof Rural) election of 401 votes could be voters if they had the mail in ballot option. Mr. Holubosh mentioned that he had calculated that 146 eligible voters had the opportunity to vote taken away because mail in ballots were not allowed.

He spoke to the need for higher voter turnout for votes and elections. The voice of more residents needs to be heard to ensure fairness and a unified movement.

Director Repen mentioned that residents that live in the region and work in a camp setting quite often, due to the timeframe for advance voting and general election day, do not have the opportunity to vote. He indicated his awareness of an additional cost but encouraged the Regional Board to consider mail in voting throughout the region.

SUBJECT: Mail Ballot Voting

In August, 2011 the Regional District of Bulkley-Nechako Board of Directors, upon the request of a number of seasonal dwellers in a portion of Electoral Area "F" (Vanderhoof Rural), specifically Cluculz Lake, adopted "Regional District of Bulkley-Nechako Mail Ballot Authorization and Procedure Bylaw No. 1617, 2011" (attached) to allow for Mail Ballot Voting within a portion of Electoral Area "F" for referenda only.

Following adoption of the bylaw, there has been one referendum which included the Cluculz Lake area where Mail Ballot Voting was used. There were 181 mail ballots requested and 162 were returned prior to the close of voting. The process was extremely onerous and time consuming.

In November, 2015 the Regional Board received a delegation from the Cluculz Lake area wherein it was requested that the RDBN consider allowing all eligible RDBN electors to vote by mail ballot for both elections and referenda. As a result, the RDBN Board of Directors requested that staff prepare a report in regard to Mail Ballot Voting.

Staff have been researching mail ballot voting and have contacted other Regional Districts to determine if they conduct mail ballot voting, and if so, what their procedures are. Out of 29 Regional Districts (inclusive of Islands Trust and Northern Rockies Regional Municipality) five do not conduct mail ballot voting of any kind, and three, including RDBN, allow mail ballot voting in specified areas only.

The majority of Regional Districts have noted that the number of electors voting by mail is relatively small. I would like to note that the number of requests for mail ballots we received from the Cluculz Lake area exceeds the number received by other Regional Districts for their entire regional district. In addition, I believe a controversial referendum will result in more mail ballot requests than an election (ie past Vanderhoof Pool Referendum).

    - o Comments It is surprising how much time it takes to process the applications. Processing registrations can take up more time, especially when packages are returned incomplete and time is spent obtaining the correct information.

Prior to March, 2008, legislation permitted mail ballot voting for electors with a disability or electors considered living in a "remote area" with a great distance from polling stations. On March 31, 2008, legislation changed which enabled local governments to expand the provision of mail ballot voting to include persons who expected to be absent from the Regional District on both general and advance voting days. Section 110 of the *Local Government Act* states that a Regional District *MAY*, by bylaw, permit voting by mail ballot.

# Typical Process for Conducting Mail Ballot Voting

• Advertisements are placed in local newspapers, as well as the P.G. Citizen for Cluculz Lake residents, indicating mail balloting information.

Mail Ballot Voting Page 3

- Upon receipt of a valid application for a mail ballot, the Chief Election
   Officer sends to the applicant a mail ballot package together with an
   application for registration as an elector.
- The Chief Election Officer records the name and address of the person to whom the mail ballot package has been sent.
- Upon receipt of a mail ballot package, the Chief Election Officer shall record the date of such receipt and remove and examine the certification envelope and the completed elector registration application and mark the certification envelope as "ACCEPTED" or "REJECTED."
- Certification envelopes remain unopened until such time as determined by the Chief Election Officer.

# Mail Ballot Voting Benefits

- Creates additional voting opportunity for eligible electors.
- May increase voter turnout for non-resident property electors and "snowbirds".
- May eliminate complaints by the public in regard to the lack of additional voting opportunities.
- May assist those with mobility challenges.

# Mail Ballot Voting Challenges

#### Mailing and Return of Ballots

- Voters are required to formally request a mail ballot package.
- For an election, ballots cannot be printed until one week after the close of the nomination period. It takes approximately one week for the ballots to be printed. This leaves about a 3 week window for the ballots to be sent to electors and returned to the Chief Election Officer prior to the close of voting.
- Will be problematic should the elector be outside of the province or the country, however, the *Local Government Act* states that it is the responsibility of the person applying to vote by mail ballot to ensure that the mail ballot is received before the close of polls on general voting day.
- Referendum ballots may be printed much further in advance, allowing sufficient time for the elector to return their ballot.

#### Cost of Mail Ballot Packages

The cost to mail out each package could range in price as follows (Canada Post Regular mail):

Canada \$1.71 - \$2.77 per package
 US \$2.68 - \$4.85 per package

- International \$5.56 \$9.69 per package
- · Prices will vary depending on the weight of the package.
- There is no way of knowing how many voters will request a mail ballot package, a total cost cannot be estimated.



#### Validity of Mail Ballots

- May be questions raised or challenges regarding the validity of the mail ballot.
- Legislation provides that the onus is on the voter signing a declaration stating that they are eligible to vote.
- Voter eligibility will be difficult to verify as the legislation does not include any regulations that require electors to provide proof that they are eligible to vote.

# Additional Staffing for Issuance and Collection of Mail Ballots

- Administrative process for mail ballot voting is very intensive.
- Additional work for the Chief Election Officer and Deputy Chief Election Officer would be required.
- If mail ballot voting were to be implemented region wide for elections, additional staffing would be a necessity. Even more staff would be required should a region-wide referendum be held.
- It is difficult to estimate the number of additional staff needed as it will be dependent on public interest.
- A minimum of 2 additional staff would be required in-house for a 3 week period to prepare ballot packages, record mail ballot requests, mail out packages, and answer telephone and email requests.
- Cost of 2 temporary full-time staff for a 3 week period is estimated to be \$4,800.
- Added cost to advertise and interview for additional staff required.

#### Additional Staffing on General Voting Day

- Sought a legal opinion in regard to implementing a deadline for the receipt of mail ballots by the Chief Election Officer prior to the close of voting.
- Does not seem reasonable that the Regional District office be staffed on general voting day in the event that a mail ballot is delivered.
- Canada Post is closed on Saturdays and Courier services in the area do not deliver on the weekends.
- The only way a mail ballot could be received would be if it was handdelivered, in which case the mail ballot should be delivered to the appropriate polling station.
- Legal opinion indicates that the legislation is not clear even though the legislation allows the Chief Election Officer to establish time limits in relation to mail ballot voting, it also states that the elector is obligated to ensure delivery of the mail ballot to the Chief Election Officer prior to the close of voting on General Voting day.
- Legal opinion indicated that if challenged, the courts would interpret the legislation in a manner that prevented local governments from imposing stricter time limits for the return of mail ballots which may pose a problem.
- Difficult for an RD Chief Election Officer to be stationed at a specific location on general voting day as there could be up to 18 polling stations operational at the same time across the region.
- CEO and Deputy CEO need to be available to attend any polling stations should issues arise.



- A legal opinion was sought in regard to appointing election officials at specific polling stations to accept any walk-in mail ballots.
- Legal opinion indicated that is reasonable, and that there is nothing in the legislation that prohibits this.
- In order for mail ballots to be accepted and opened at specific polling stations, 2 additional election officials would be required at each of the specified polling stations to receive walk-in ballots and count all mail ballots received at the close of voting.
- Due to the lack of RD ability to impose timelines in relation to a deadline for receipt of mail ballots, all mail ballots will be in the possession of the CEO at the close of voting on the day prior to general voting.
- It has been the practice of the RD to combine ballot boxes containing less than 25 ballots with another box, as per Section 137 of the *Local Government Act*, for the purpose of preserving the secrecy of the ballot.
- Mail Ballots received at the RD office would have to be delivered to the appropriate polling station prior to the close of general voting.
- Hiring up to three additional staff to deliver the ballots may be required.
- Advertising costs would increase as 2 additional newspaper ads would be required for each election/referendum specific to Mail Ballot Voting.
- Newspaper ads are extremely expensive.

#### Financial Implications

Increased costs to implement mail ballot voting are difficult to quantify as it will be partially dependent upon how many electors choose to vote by mail ballot, and how many areas are impacted by the election/referendum. The costs to mail the packages would vary depending on the size of the package and where the package is being sent. In addition, the number of additional staff required inhouse to administer the process would depend upon the scale of the election/referendum. Following is a list of additional costs:

# Summary

Changes to the *Local Government Act* have expanded the provision of mail ballot voting to eligible electors who expect to be absent from the regional district on advance and general voting days. There are significant challenges with the implementation and provision of mail ballot voting. The benefits are unknown at this time, although it does provide an opportunity for non-resident property electors to vote.

MINISTRY OF COMMUNITY, ABORIGINAL & WOMEN'S SERVICES The ministry supports initiatives that increase public participation in the general local elections. A questionnaire was sent to local government election officers last year about their experiences with the 2002 general local election. The purpose was to determine where practitioners were experiencing difficulties, whether improvements in the legislation are needed, or whether additional informational material is needed. One of the questions asked was whether the respondents supported mandatory mail ballot voting. Twenty local governments supported mail ballot voting and fifty-three did not support it. The questionnaire results are not necessarily a rejection of mandatory mail ballot voting. However, there were sufficient concerns expressed about the additional administrative burden that would be imposed on smaller local governments that further consultation on the issue will be needed. The ministry will undertake further consultation with local



governments on this matter and any others that might increase public participation in general local elections.

#### Mail ballot voting

- 110 (1) Subject to this section and any regulations under section 168 [election regulations], a local government may, by bylaw, permit voting to be done by mail ballot and, in relation to this, may permit elector registration to be done in conjunction with this voting.
  - (2) For a municipality, the only electors who may be permitted to vote by mail ballot are
    - (a) persons who have a physical disability, illness or injury that affects their ability to vote at another voting opportunity, and
    - (b) persons who expect to be absent from the municipality on general voting day and at the times of all advance voting opportunities.
  - (3) For a regional district, the only electors who may be permitted to vote by mail ballot are
    - (a) persons who have a physical disability, illness or injury that affects their ability to vote at another voting opportunity,
    - (b) if, for this purpose, a bylaw under subsection (1) specifies an area on the basis that it is remote from the voting places at which persons who reside in the specified area are entitled to vote, persons who reside in that specified area, and
    - (c) persons who expect to be absent from the regional district on general voting day and at the times of all advance voting opportunities.
  - (4) A bylaw under subsection (1) may
    - (a) establish procedures for voting and registration that differ from those established under other provisions of this Part, and
    - (b) establish, or authorize the chief election officer to establish, time limits in relation to voting by mail ballot.
  - (5) The chief election officer must give notice of an opportunity to vote by mail ballot in any manner the chief election officer considers will give reasonable notice to the electors who will be entitled to vote by this means.
  - (6) The procedures for voting by mail ballot must require the chief election officer to keep sufficient records so that challenges of an elector's right to

vote may be made in accordance with the intent of section 126 [challenge of elector].

- (7) Mail ballot packages must contain the following:
  - (a) the ballot or ballots to which an elector is entitled;
  - (b) a secrecy envelope that has no identifying marks, in which the ballots are to be returned;
  - (c) a certification envelope on which is printed the information referred to in subsection (8) for completion by the person voting, in which the secrecy envelope is to be placed;
  - (d) an outer envelope on which is printed the address of the chief election officer at the local government offices and in which the envelopes under paragraphs (b) and (c) and, if applicable, the registration application under paragraph (e) are to be returned;
  - (e) if permitted by the bylaw under subsection (1), an application for registration as an elector, to be completed if necessary and returned in the outer envelope;
  - (f) instructions as to how to vote by mail ballot.
- (8) The certification envelope must be printed
  - (a) with spaces in which the person voting is to record his or her full name and residential address, and
  - (b) with a statement to be signed by the person voting declaring that the person
    - (i) is entitled to be registered as an elector for the election,
    - (ii) is entitled to vote by mail ballot, and
    - (iii) has not previously voted in the election and will not afterwards vote again in the election.
- (9) In order to be counted for an election, a mail ballot must be received by the chief election officer before the close of voting on general voting day and it is the obligation of the person applying to vote by mail ballot to ensure that the mail ballot is received by the chief election officer within this time limit.
