Minister Rustad indicated he will request that Northern Health reduce the contribution for the cost to convert a lease space to meet the provincial health requirements for a new Primary Care Facility in Fort St. James from the typical 40% of the cost of replacing health care facilities through local taxation to only 20% of the capital costs. This funding model is similar to the model used for the Lakes District Hospital and Health Care Centre. The SNRHD will follow up with Minister Rustad and Northern Health in regard to the SNRHD's contribution to the Fort St. James Primary Care Facility.
