Ms. Petrucci noted that there will be approximately 400 short term and 60 long term jobs with Spectra Energy's Westcoast Connector Gas Transmission Line.

The release of the 2014 B.C. Provincial Budget and the two-tier LNG Income Tax was brought forward for discussion.

Discussion took place regarding the recent LNG meeting that was hosted by the Carrier Sekani Tribal Council and Spectra Energy's engagement with First Nation communities. Ms. Petrucci spoke of their involvement at collective workshops and meeting with First Nation communities individually.

Director Bachrach spoke of having open dialogue and the challenges of conversations with communities regarding the impacts and benefits along with the overwhelming amount of information being presented by the various LNG (Liquid Natural Gas) Transmission Line companies proposing to transport LNG through the region. Discussion took place regarding the opportunity for industry to attend public forums hosted by communities. There was a recent public forum held in Smithers that was hosted by Nathan Cullen, MP, Skeena Bulkley Valley that was well attended, and could have been an opportunity for industry to attend. Mr. Genge noted that he did attend the event to listen and hear concerns. Ms. Petrucci mentioned that Spectra Energy welcomes any invitation to attend community events and or individual meetings with community stakeholders. The effectiveness of open houses was brought forward for discussion.

Director Bachrach noted that the First Nation communities requesting the pipeline companies to engage with them individually also applies to all communities and may be an effective mechanism to communicate.

Mr. Genge spoke of the history of Spectra Energy in B.C. and the long term investment in the communities the people and the project. Spectra Energy's goal is to remain open, honest and transparent and take feedback from the public to determine the direction of community consultation.

SPECTRA ENERGY Franca Petrucci, Community Coordinator and Graham Genge, Community Coordinator RE: Update (CONT'D)

Discussion took place regarding transparent communication in reporting failures to the National Energy Board (NEB). Pipeline integrity and safety must be of the utmost importance. Ms. Petrucci mentioned that Spectra Energy's priorities are safety and the environment. Spectra Energy funds \$250 million per year for safety and integrity programs. There are two twenty four hour monitoring stations on its pipeline.

The harvesting of fibre along the right of way was commented on. Ms. Petrucci mentioned that Spectra Energy intends to harvest everything that they can and pay the stumpage. There may be some fibre that is not harvestable but they will be working with local First Nations, license holders and contractors to utilize all the possible fibre. Spectra Energy is supportive of harvesting fibre on right of ways being made a requirement by the provincial government.

Director Stoltenberg spoke of utilizing transmission line corridors for pipelines and minimizing the impact to the land base and timber supply. Mr. Genge explained that depending on the type and size of pipelines in proximity to transmission lines they have to adhere to the regulations and classifications from the Oil and Gas Commission and the Oil and Gas Activities Act. There are a number of considerations given such as a conductivity factor, safety, public input from First Nations and stakeholders, and geotechnical studies. There are areas wherein the pipelines parallel and/or utilize existing right of ways. Spectra Energy has considered in its planning the importance of a limited footprint and the possibility of two pipelines utilizing the same corridor.

Chair Miller noted that in a recent meeting with Chief Teegee, Carrier Sekani Tribal Council similar concerns were discussed regarding the need for open communication and transparency from the pipeline companies along with the need to address the removal of fibre and impact to the midterm timber supply with the possibility of numerous pipelines traveling from the northeast to the northwest of B.C. It is important to continue to communicate with communities and take direction from the numerous communities and First Nation communities within the region.

Chair Miller thanked Ms. Petrucci and Mr. Genge for attending the meeting.

SEARCH AND RESCUE Chris Mushumanski and Andy Muma RE: Grant in Aid Application

Chair Miller welcomed Chris Mushumanski and Andy Muma, Search and Rescue.

Mr. Mushumanski and Mr. Muma presented a PowerPoint Presentation.

Search Rescue is a complete volunteer organization. In the North:

- 5 teams in the Regional District of Bulkley-Nechako;
- Smallest team consists of 15 members and the largest team consists of 60 volunteers;
- Provincially there are 2,500 volunteers;
- Underserved in terms of geography;
- Often large searches require outside teams from the north or other regions in the province.

SEARCH AND RESCUE Chris Mushumanski and Andy Muma RE: Grant in Aid Application

Search and Rescue provides:

- Searches;
- Rescuing;
- Assistance to the RCMP, B.C. Coroner and Ambulance in the recovery of remains;
- Assistance to the RCMP in evidence searches;
- Assisting the Regional District of Bulkley-Nechako in delivering Evacuation Alerts and Orders:
- Provide a wide range of services.

In 2013 - Unusual circumstances but a growing trend;

- large multi-day searches
 - Francois Lake;
 - Fort St. James;
 - Takysie;
 - Also assisted Terrace Search and Rescue.

In June, 2013 during the large multi-day search at Francois Lake new technology was used that produced mapping within a 30 minute timeframe instead of hours or days that it took in the past.

September, 2013 Regional Training

- First regional training opportunity in 13 years;
- Due to it being a volunteer base organization funding training events are challenging.

Mr. Muma mentioned that he is employed by the Province of B.C. in the Skeena Region as a Land Information Coordinator and has been a member of Search and Rescue for three years. His work involves applying technology to work flow. He is a member of a twelve person team and they have been implementing mobile technology throughout B.C. in all areas of mid-level government. He has been presenting the information to government and the private sector in the last year along with members in the emergency response field such as RCMP, doctors, nurses, Search and Rescue and flood control personnel.

There is a significant technology change currently taking place and he is taking his experience in government and applying it to Search and Rescue.

Mr. Muma provided a demonstration of the application to the Regional Board.

Mr. Mushumanski noted that on March 29, 2014 a training day for the technology presented today has been planned in Houston, B.C. for the Search and Rescue teams within the RDBN. The intent is to supply SAR Managers and Team Leaders with Ipads with the technology application. The Ipads are a special order item and will take 2 to 3 weeks for delivery. On May 2, 2014 Search and Rescue from 100 Mile House north will be meeting and Mr. Muma will present the technology. The ability for teams to work together quickly and utilize the same applications through a common use of technology that will improve search and rescue delivery across the region and province will be an enormous benefit.

Chair Miller thanked Mr. Mushumanski and Mr. Muma for attending the meeting.

Director Newell mentioned that while at Minerals Roundup a resource portal was suggested as a possible benefit. Chair Miller mentioned that it may be an economic strategy to be discussed in the future.

ADMINISTRATION REPORTS (CONT'D)

Concerns were brought forward in regards to CN's emergency response. There is no evidence or assurance that indicates that CN has teams and equipment in place to respond quickly and effectively in proportion to what is being transported via rail.

Director Bachrach noted that CN has requested that the meeting in Smithers is to be a closed meeting and the only attendees be Mayor Bachrach and the Town of Smithers Chief Administrative Officer.

Gail Chapman, CAO reported that staff has recently applied for CN's Annual Report of Goods Transported throughout B.C.

Discussion took place regarding the issue that if an event does occur the first responders in the region will lack sufficient training to be able to respond. The need for funding for training of local responders and the importance of CN providing details of goods being transported through the communities within the region was discussed.

In the past when a derailment occurred near the District of Vanderhoof, CN did not report the event to Vanderhoof. Frustrations were brought forward regarding the lack of communication involving CN. Discussion took place regarding CN being regulated by Transport Canada.
