DISCUSSION ITEMS

1. 2013 Budget - Costs Per Director to Attend Conferences and Conventions

Discussion took place regarding the cost benefit and value of Directors attending conferences and conventions. The importance of being part of the development process and providing input into policy making was discussed. Chair Petersen spoke of the opportunity to meet with Ministers and bring issues forward as an important component of being an elected representative.

2. Public RDBN Budget Meetings in Rural Areas

The outline of past public meetings was discussed. The topic of the meeting often determines public attendance. Rural Directors and rural residents were invited to attend the Public RDBN Budget meetings held at municipal council chambers in 2012. Due to time constraints and capacity it may be challenging to provide separate public meetings in the seven electoral areas thus the ability to include the rural and municipal residents in the public budget presentations at the eight municipal council chambers is beneficial.

During the 2012 Public Budget Presentations the Regional District advertised in the newspapers throughout the region for both rural and municipal members of the public to attend the meetings.

Hans Berndorff, Financial Administrator mentioned that the meetings would also be posted on the events calendar on the Regional District of Bulkley-Nechako website.

Alternate Director Ponsford spoke of Director Roy's request to have a meeting in Electoral Area "D" (Fraser Lake). Discussion took place regarding having rural members attend the public meeting scheduled at the Village of Fraser Lake Council Chambers.

Director Stoltenberg noted that Rural Directors may take the initiative and present budget information obtained from the Financial Administrator to members of the public.

Staff will advertise the meetings in local papers and on the events calendar on the RDBN website.

DISCUSSION ITEMS (CONT'D)

3. Parks and Recreations - NDI Funding Pool

Director Miller spoke of the possibility of utilizing the NDI Funding Pool for parks and recreation sites within the Regional District of Bulkley-Nechako. He mentioned that parks and recreation sites are not only used by local residents but are also an intrinsic part of the lifestyle along with attracting individuals traveling through the region.

Discussion took place regarding construction of docks and improving current sites. Once the parks and recreation sites are constructed, the possibility of establishing a Regional District service function was also discussed.

We organise and host the Pacific NorthWest Regional Science Fair for over 100 students, assisted by about 50 volunteers, as well as providing resources throughout the year to support student projects. At the Regional Science Fair, students present their projects to the professional scientists, technologists and educators who donate their time to inspire students to take the next step in their scientific thought. We provide lunch and an afternoon of volunteerled scientific activities for participants. We provide prizes and awards based on merit and effort and select students (up to four depending on funding) to represent our region at the annual Canada-wide Science Fair which will be held in Lethbridge Alberta in 2013. These hard-working young scientists will join 500 other students from across the country for a life-changing week of competition, science education, cultural activities and fun. Many of our students come home with awards and university entrance scholarships. All return excited about opportunities in science, engineering and medicine in Canada. We are requesting assistance with funding our annual Regional Science Fair and with supporting registration in the Canada-wide Science Fair for qualified regional students.

Describe how this proposal will benefit the community.

This project directly benefits the young people of our community. It fosters scientific inquiry among young people, helps young scientists demonstrate their research and provides young scientists with professional feedback. Students learn that science and innovation research is fun and rewarding. Most young people love asking questions. Science fair gives them an opportunity to learn how to answer these questions for themselves, from concept to presentation. Sometimes students learn that unexpected results can be more interesting than the "right"

answer. Many scientists and innovators get their start at regional science fairs. In this way, the project benefits us all, as it provides the platform and excitement that encourage young scientists to continue their quest to answer questions and solve problems. Even students who don't go on to be scientists benefit from the creative, organisational and communication skills they learn while completing their projects. Some students who find classroom learning challenging shine when given the opportunity to work in depth on their own ideas.

COMMENTS:

This application is an amendment to Investigative Use Permit 7408806 for wind feasibility studies in the Nulki Hills area. The applicant has applied to amend the boundary of the permit area based on available wind resource data, topographical features and to avoid a large wetland complex. The permit area has also been increased from 4993 ha to 5001 ha in size. One meteorological tower location was moved from the original application area.

The proposal was first referred to the Regional District in 2008 for a Licence of Occupation for five specific sites where the wind power monitoring towers were to be located. The proposal was referred to the Regional District again in 2010 when the area was expanded from 2,885 ha to 4,936 ha. The proposed Nulki Hills Wind Project is currently in the pre-application phase of the environmental assessment process. It is noted that the Planning Department is participating as a member of the Working Group for the Nulki Hills Wind Project Environmental Assessment Process.

The Regional District has no land use regulations in this area. It is recommended that the Rural Directors take the position that the Regional District of Bulkley-Nechako has no objections to Land Referral Application No. 7408806. Staff will respond to the Ministry with the Rural Directors' position.

This proposal is for a sale of Crown Land (Block B, District Lot 3419, Range 5, Coast District). The applicants now wish to purchase the land they have leased since 1989 and where they are operating the Nadina Mountain Wilderness Lodge. The property is 4.05 ha in size and located on the western shore of Owen Lake, approximately 30 kilometres south of the District of Houston. The facility consists of a main lodge and two log cabins and offers lodging, conferencing and base camp facilities for up to 20 people.

The property is zoned Rural Resource (RR1). The use does not comply with the Regional District Zoning as a resort lodge is not a permitted use in the RR1 zone. 



Ve have leased this property since 1989 and are now applying to purchase: Part NE ½ District lot 3419 Range 5 Land District #633544 LB02723134

The name Na-di-na Mountain first appeared on the 1879 Geological Survey of Canada map of BC & NWF. Nadina means "Standing Up Alone", referring to the prominent, solitary aspect of the mountain.

Nadina Mountain Park encompasses an isolated granitic mountain rising up from the rolling terrain of the Nechako Plateau. The mountain is a unique and dominant feature on the landscape and is theorized to have been a refuge during the last glaciations. Unique rock formations include large granite pillars. Heavy forest below gives way to expansive alpine tundra on the summit plateau. The park provides good habitat for mountain goats. Recreational use in the park includes hiking, rock climbing, wildlife viewing and hunting. The park is a popular regional destination for hikers.

There is a strenuous hiking route up the northeast slope of Nadina Mountain. The trail leads from an old cut block outside the Park, through the forested slopes of the mountain and up to alpine. The trailhead is at 867-meter elevation and reaches alpine at 1686 meters. After reaching alpine, the trail fades away. From this point, hikers can pick their own route to the summit at 2125m.

Another route up the mountain leaves from Nadina Mountain Lodge on Owen Lake. This is a longer route that visits both Klate Lake and Base Lake en route to the mountain and then climbs steeply.

Tourists usually stay a few days up to a week enjoying the quiet retreat atmosphere. In the fall and early winter, resident hunters book a year in advance and stay up 3 weeks. Fishing season is early summer to fall and the length of stay is on average a week. Throughout the late spring, summer and fall we have catered to local groups and corporations for planning retreats and daytrips. In the fall the Gitxsan Education Society and Band Council have sponsored traditional cultural educational trips for youth and families. Corporate crews (tree planting, mining, brushers and thinners, hydro and pipelines) stay from 1 to 3 weeks, throughout the year.

The majority of activity occurs in the spring – summer –fall seasons. There are a number of cross-country skiing and snow shoeing enthusiast that will come and enjoy their stay mid winter, to enjoy the pristine deep snow and accessing trails along Owen Lake. Our family has enjoyed many Christmas's at Nadina Mountain Wildemess Lodge.

Utilities are:

- Wood heat -- we are currently getting our firewood supply from the bug wood that we have started to clear out (to prevent forest fires and dead fall).
- Propane stove and fridge
- Diesel Generators, we very rarely use, due to pollution, noise and cost of fuel. We are selling the generators and expect to convert to solar/wind within 2 years.
- Water supply Well and water license # CO34415 Klate Creek
- Sewage disposal closed septic system required.

Access is by private road access, which we have maintained for the past 23 years with yearly grading, maintance and a new bridge over Klate Creek. We also have boat access from our property (Block A, District lot 3433, Range 5) that has been family owned for the past 54 years (since 1958) across the lake from the lodge.

Because Nadina Mountain Park provides important ecosystem services (the benefits that people receive from ecosystems) that include clean water, natural flood control, carbon storage, air purification, nutrient cycling, food, biodiversity, recreation, aesthetic experience and spiritual experience. We have been very careful to rebuild green and look to the future to continue supporting the environments efforts in these areas. Even our boats, in reference to environmental concerns, are non-motorized a rowboat and a sailboat.

Over the years Nadina Mountain Wilderness Lodge has catered to a variety of demographics that include:

- First Nation educational programming and retreats: supporting First Nation activities throughout the years. Nadina Mountain Wilderness Lodge is 100% Native owned so we deeply understand the potential benefits, partnership opportunities, special interests and concerns, of First Nations.
- Hunting and fishing rentals.
- Hikers and photographers
- Local community entities
- Corporate crews from the mining, logging, hydro and pipelines.

As recreation and tourism is also part of the Morice Land and Resource Management Plan (LRMP). Our mandate also includes; educating and supporting hikers, photographers, hunting and fishing enthusiasts. Nadina Mountain Lodge continually discusses park values, avoidance of Mountain Goats, bear-human interactions, and trail conditions (e.g., steep, some sections with slippery rocks, no water on the mountain top, etc.). Further supporting that all of Nadina Mountain Park is zoned Wilderness Recreation to protect a remote, undisturbed natural landscape, to provide backcountry recreation opportunities, and to reflect the non-motorized designation of the park by the Morice LRMP. Motorized recreational activities, including helicopter access, are not permitted in the park.

The Gitxsan and Wet'suwet'en have traded and partnered for centuries. Although we are Gitxsan we have family and friends that are Wet'suwet'en. We have also worked with the Gitdumden (Bear/Wolf) clan and the George Family over the years to maintain a working relationship in the common goal of the preservation of Nadina Mountain Park.

We are in the midst of major renovations to the main lodge, as it was ravaged by vandals last spring. The future will be rebuilding the main lodge and renovations have already started to the "Hanger" and the two log cabins. In keeping with the "retreat" theme of Nadina Mountain Wilderness Lodge, the only communication devise will be by VHF radio, for safety. There is no cell service, internet, electricity or phones. All aspects of the renovations and re-build will be on the forefront of "off the grid" environmental construction.

With this reawakening, comes a fresh start, and a new direction. The Nadina Mountain Wilderness Lodge at Owen Lake welcomes visitors from around the world who soek a comfortable base from which to explore the exceptional culture and nature of Nadina Mountain.

The Nadina Mountain Wilderness Lodge is surrounded by nature- forest, open sky and water. The front of the lodge faces the serene Owen Lake; to the back rises Nadina Mountain, which hosts Nadina Mountain Park. The newly renovated log cabins provide comfortable accommodation for up to 10 guests and when the lodge renovations/rebuild is complete we will once again be able to accommodate up to 20 people.

Nadina Mountain Lodge offers lodging, retreats, conferencing and base camp facilities. It is the only such entity on Owen Lake, aside from the provincial campground. We are able to support and monitor the usage of Nadina Mountain Park and Owen Lake to a certain degree. For instance 2 years ago when the forest fires where raging, we found a party happening at the provincial camp grounds with a huge open fire, due to our presence the fire was put out and people settled down. We have make sure all of our guests understand that the conservation role of Nadina Mountain Park is to protect a unique isolated granitic mountain and its associated natural values, including:

- Mountain goats
- Grizzly bears
- Lichen communities
- Granitic spires.

Nadina Mountain Pork is a regional destination; activities include hiking, mountaineering, wildlife viewing, rock climbing and hunting. Every weekend there are hikers and photographers accessing Nadina Mountain Park. Photographers find the mineral lick which is located just northwest of the park boundary an exceptional location for photos. The expectation that is hiking/climbing traffic will increase due to the popularity of climbing the Berkey-Howe Union Spire, a freestanding granite pillar located at the head of the large circue on the northeast exposure of Nadina Mountain. Formations like this are very rare in granite. The spire is approximately 40 m tall, and the summit is an exposed 2 m x 2 m platform.

Nearby parks that can be accessed during our clients stay at Nadine Mountain Wilderness lodge are: Bernie-Shea Park 40 km to the northwest, Bernie River Protected Area 60 km to the northwest, Anta River Park 50 km to the west, Murices Lake Park 30 km to the west, Nenikekh/Nanika-Kidprice Park 25 km to the southwest and Old Man Lake Park 50 km to the northeast. These moderate to large backcountry parks were established to increase representation of regionally significant ecosystems, to provide opportunities for unroaded wilderness recreation, and to protect cultural horitage resources. Other nearby protected areas include: Morice River Ecological Reserve 15 km to the north, Topley Landing and Red Bluff parks 90 km to the northeast, Babine Mountains Tweedsmuir Park 40 km to the southeast.
