Solid Waste Management Plan Project Schedule

The Environmental Services Department would like to present the Solid Waste Management Plan (SWMP) project schedule to the Waste Management Committee and the Board of Directors for receipt.

Tetra Tech Canada has been awarded the project contract for the SWMP review and update on September 21, 2017. The Environmental Services Department met with the consulting team via telephone conferencing on October 10, 2017 to kick-off of Stage One of the project and to prepare for the site visits that will occur on October 24-26<sup>th</sup>, 2017. The following is the proposed methodology to complete the project:

#### Stage1: Project Initiation and System Assessment

 Kick-off meeting, project planning meeting and site visit, current system assessment and presentation to the Advisory Committee (Workshop #1).

#### Stage 2: Plan Update and Stakeholder Engagement

Development of options, presentation of options to the Advisory Committee (Workshop #2), development of financial analysis, presentation of financial analysis to the Advisory Committee (Workshop #3), stakeholder engagement, development of a consultation plan, presentation of the SWMP elements and the consultations plan to the Advisory Committee (Workshop #4), development of a SWMP Update Issued for Review.

### Stage 3: Public Consultation and Plan Update

 Preparing consultation materials, facilitating public consultation, preparing a consultation summary report, finalizing the 2018 SWMP Update Issue of Use.

Included with this Memorandum is the proposed Project Schedule. Dates for the Workshops will be scheduled closer to the proposed dates to take into consideration of project timelines and staff and consultant schedules.
