SUBJECT: Caribou Recovery Program

DATE: April 17, 2018

The main RDBN Board Agenda for April 19, 2018 includes a document entitled "Provincial Caribou Recovery Program Discussion Paper". While Caribou herds in northern British Columbia are under threat and action is required to protect the caribou herds, these actions can have a significant impact on forestry, mining and recreational use of land. The federal government's legislation seeks to protect the caribou herds and caribou habitat in isolation whereas the Province has stated that their caribou recovery efforts balance the socio-economic impacts and that they intend to collaborate with local interests.

The Province has indicated that it would be helpful to have a letter of support to the federal government from the RDBN and other local governments who would like to collaborate in the development and implementation of the Caribou Recovery Plan. A draft letter is attached for the RDBN Board's review and consideration.

RE: Support of the Province of B.C.'s Caribou Recovery Program

The Board of the Regional District of Bulkley-Nechako (RDBN), would like to request that Ottawa support the Province, in collaboration with all relevant local interests and inclusive of local governments, to develop and implement Caribou Recovery Program to maintain and recover BC's caribou herds.

The RDBN agrees with Minister Donaldson, FLNRORD's opening remarks, in the Provincial Caribou Recovery Program Discussion Paper, that it is important to "reduce threats to caribou, while balancing the needs of all British Columbians, including Indigenous communities, industry and recreation enthusiasts."

We cannot understate the need to balance socioeconomic needs while developing plans to maintain and recover caribou. Forestry, mining, and recreation are important values that must be considered concurrently with the caribou recovery. The Province has advised that it aims to include local governments in developing predictable zonation and thresholds to provide certainty to affected natural resource users.

The RDBN is committed to work with the province to plan natural resource utilization that supports our local communities and minimizes impacts to local caribou herds. Minister Donaldson has committed to involving local governments in the caribou recovery to ensure that local knowledge and priorities are incorporated as we move forward.

B12: SOUTHERN MOUNTAIN CARIBOU

PEACE RIVER REGIONAL DISTRICT

WHEREAS the Southern Mountain Caribou has been identified as a species at risk and the Province has announced a draft conservation agreement under the federal Species at Risk Act regarding recovery measures for the Southern Mountain Caribou, the goal of which is to articulate the actions the Parties will take over the next five years to support the long term objective of achieving recovery of self-sustaining populations of the Southern Mountain Caribou in BC;

AND WHEREAS the initial focus includes the Pine, Narraway, and Quintette Local Population Units in in the Peace River Regional District in northeastern BC:

THEREFORE BE IT RESOLVED that the NCLGA and UBCM request that the Provincial Government consider the impact of actions proposed to assist with the recovery of the Southern Mountain Caribou will have on back country access, which is integral to the success of Tourism in northeast BC;

AND BE IT FURTHER RESOLVED that the Province be requested to commit to involve the Canadian Food Inspection Agency in the process as they have significant knowledge regarding health concerns specific to the Southern Mountain Caribou and potential impacts to other domestic and wild animal species in the region.

UBCM COMMENTS:

The UBCM membership has not previously considered a resolution calling for the Province to consider the impact of South Caribou recovery actions on back country access, and for the involvement of the Canadian Food Inspection Agency. However, the membership endorsed Resolution 2017-B114 that called for the Province to investigate and consider the socio-economic impacts of implementation plans for the conservation and regeneration of woodland caribou in BC. In response to the resolution, the Province acknowledged that a socio-economic assessment is developed to inform decisions on all species-at-risk implementation plans.





B114 Woodland Caribou Implementation Plan Consultation

Whereas the Province, in compliance with the federal Species at Risk Act, is currently in the process of developing implementation plans for the conservation and regeneration of woodland caribou in BC;

And whereas such plans, by restricting the harvesting of timber in specified areas can have a significant negative impact on forest industry investment operations, and local economies:

Therefore be it resolved that UBCM request that the provincial government immediately commit to meaningful consultation with local governments potentially affected by woodland caribou implementation plans, such consultation to involve thorough investigation and consideration of socio-economic impacts.
