He noted that the individual that provides the vehicle is given an allowance for kilometres travelled but no incentive for passengers in a car pooling arrangement. He spoke of the potential cost savings in creating a car pool incentive program wherein the vehicle owner and passengers receive an allowance. Concerns were raised in regard to scheduling issues. Chair Miller spoke of the option for carpooling if the opportunity arises. Discussion took place in regard to compensation for travel time. Director Fisher mentioned the benefit of having further discussion in regard to carpooling targets. Director Thiessen spoke to staff bringing forward a report providing an outline of possible carpooling targets.

Discussion took place about reducing greenhouse gas emissions in regard to heating the Bulkley Valley Pool. Director Bachrach spoke to the challenges of moving forward with heating initiatives for the Bulkley Valley Pool. Director Repen mentioned that along with Director Fisher and Town of Smithers Councillor Brienesse they have emphasized that the proposed Facility Condition Review for the Bulkley Valley Pool contain an energy efficiency review. He noted the challenges in regard to four of the buildings that could be part of an energy efficiency project along with the Bulkley Valley Pool not being owned by the RDBN

but the Town of Smithers and School District 54 Bulkley Valley.

Chair Miller suggested that a further discussion at a Committee of the Whole Meeting in regard to the CARIP Report may be beneficial. Further discussion by Directors directly involved and impacted by the Bulkley Valley Pool would be advantageous.

Roxanne Shepherd, Chief Financial Officer mentioned that the Bulkley Valley Pool Manager has issued a Request for Proposals (RFP) for the Facility Condition Assessment and is currently developing an RFP for an Energy Assessment study that will be released at the close of the Facility Condition Assessment RFP. The studies will be a component of the RDBN's Asset Management planning.

Frustrations were expressed in regard to TransCanada's response to the request for information concerning their proposed work camps.

Land use development tools that the Regional District can utilize in regard to proposed work camp development areas was discussed. Approximately half of the Coastal GasLink Pipeline proposed work camps are on zoned lands. The Prince Rupert Gas Transmission Pipeline proposed work camps are located in more remote areas. TransCanada has indicated they don't want to submit a Temporary Use Permit Application prior to hiring a contractor to build the pipeline. Staff raised concerns in regard to the timeline that may be created and liquid waste disposal. Discussion took place in regard to options to build possible legacies for communities in regard to future liquid waste management.

<u>Village of Burns Lake</u> -Charitable Tax Receipts Director Illes mentioned that the Village of Burns Lake Council has concerns in regard to the issuance of Charitable Tax Receipts to local organizations and individuals and has stopped issuing receipts. The Village of Burns Lake is currently researching their options to develop a policy. They have received a number of complaints from organizations and individuals since the announcement that they will no longer provide Charitable Tax Receipts at this time.

Endako Mines – Update

Director Lindstrom reported that an Endako Mines representative attended the Village of Fraser Lake Council meeting and provided an update. Endako Mine is currently under a care and maintenance shutdown and there are currently eight people on staff. They will be hiring two more individuals and have received over 100 applications for the two positions. They have also planted more grass surrounding the tailings ponds to mitigate and contain the dust.

Bulkley Valley Co-existence Workshop – May 18, 2017 -Smithers Director Parker mentioned that he attended the Bulkley Valley Co-existence Workshop in Smithers, May 18, 2017 hosted by Director Fisher. He noted that the discussion in regard to genetically modified organisms vs. non-genetically modified organisms (GMO's) was very beneficial. There was a good cross section of individuals in attendance in regard to GMO vs. Non-GMO farming practices. Director Parker will bring forward further information at a future Agriculture Committee meeting.

Director Fisher commented that Brent Barclay, Regional Manager, Interior, Ministry of Agriculture was in attendance and it was beneficial to have his input. Director Fisher mentioned that the workshop provided a good opportunity for open communication and discussion.

VERBAL REPORTS (CONT'D)

<u>Juvenile Sturgeon Release</u> into the Nechako River

Director Thiessen attended the juvenile sturgeon release into the Nechako River at Riverside Park on May 11, 2017. In attendance were the Honourable Shirley Bond, Minister of Jobs, Tourism & Skills Training & Minister Responsible for Labour, Todd Doherty, MP Cariboo-Prince George and Art Kaehn, Chair Regional District of Fraser-Fort George. Rio Tinto was also in attendance.

Director Thiessen along with his children and grandchildren spent last evening assisting and stirring spawning sturgeon eggs.

Physician Recruitment -District of Vanderhoof

Director Thiessen mentioned that two physicians have been recruited for the District of Vanderhoof in the coming year. Work is also continuing in regard to the recruitment of a surgeon for St. John Hospital.

<u>District of Vanderhoof Raising</u> <u>Concerns in Regard to Drugs</u> and Crime in the Community

Director Thiessen noted that the District of Vanderhoof has raised concerns in regard to the drugs and crime in the community and a recent drug seizure where a number of individuals were arrested. The District of Vanderhoof has written a letter in the past to the courts in regard to expelling individuals from the community.

He also spoke to concerns in regard to the opioid crisis that is occurring and the need for further discussion to be proactive.

Softwood Lumber Agreement Meeting

Director Thiessen commented that Chair Miller organized a meeting in Terrace during the 2017 NCLGA Convention May 3-5, 2017. He noted the importance of being proactive in regard to the potential impacts of the softwood lumber agreement to the region. He mentioned the need to invite John Brink, Brink Forest Products Ltd. to a future RDBN Meeting.

<u>District of Fort St. James Fire</u> Chief Steps Down

Director MacDougall mentioned that the District of Fort St. James Fire Chief recently stepped down and they are in the process of hiring a replacement.

<u>District of Fort St. James</u> <u>Welcomes Syrian Family</u>

Director MacDougall spoke of the volunteer community members in the District of Fort St. James that have worked to bring a Syrian refugee family to the community.

Invasive Weeds in Seymour Lake in Electoral Area "A" (Smithers Rural)

Director Fisher commented that he has been working with residents living near Seymour lake in Electoral Area "A" (Smithers Rural) that is considering a service area to mitigate the invasive weeds that are overrunning the lake.

Cycle 16 Bike Trail Group

Director Fisher noted that he along with RDBN staff, has been working with the Cycle 16 Bike Trail Group in Electoral Area "A" (Smithers Rural).

He also thanked Director Parker for attending and providing assistance at the Bulkley Valley Co-existence workshop.

Northwest Community College Closes in Houston

Director Brienen mentioned that Northwest Community College (NWCC) announced that it would be closing its campus in Houston. He stated that the community is in the process of determining next steps as a number of programs were linked to NWCC, the high school, alternate school and Houston Link to Learning.

Bulkley Valley District Hospital Mammography Unit

Director Bachrach reported that the Bulkley Valley District Hospital is in need of a new digital mammography unit. The current analog machine is at the end of its life. Northern Health is replacing analog mammography units in Prince Rupert and Terrace and has indicated it is uncertain if it will replace the unit at the Bulkley Valley District Hospital. Northern Health has suggested the use of a mobile unit for screening in Smithers and for diagnostic services, which are currently offered at the Bulkley Valley District Hospital. Patients would need to travel to Terrace. Director Bachrach spoke of the importance of having a fixed unit at the hospital and the need for support from the northern region. The Northwest Regional Hospital District meeting is being held tomorrow, May 26, 2017 and Northern Health will be in attendance to discuss the issue.

Village of Telkwa Water Tower

Director Repen mentioned that the Village of Telkwa is expecting an announcement in the near future in regard to funding to move forward with the engineering and archaeological assessment for its water tower replacement project. He commented that further grant funding applications would need to go forward to move the project beyond the assessments. Director Repen spoke of the challenges faced by the small community in regard to sewer and water infrastructure upgrades.

Director Thiessen spoke to potentially having community meetings for parents and community members. Some of those groups are being provided the kits and training. The RCMP has made it one of their priorities in terms of intervention and harm reduction education. He mentioned that recently support has been provided for a program called Family Smart. The Program provides Parents In Residence (PiR). parents that have experienced youth with substance abuse, to provide support for parents and youth that are susceptible to substance use. Director Thiessen mentioned the need to speak with the schools, Northern Health and RCMP to be proactive in regard to opioid overdoses in communities. Director Brienen mentioned that the Northwest Regional Hospital Board of Directors is meeting tomorrow and he spoke of bringing forward the issue and possible supports available along with Northern Health potentially hosting Naloxone training sessions.
