#### **REPORT (CONT'D)**

Director Miller brought forward concerns in regard to the need to choose one project over another and the challenges of the pooled funding approach in which Northern Development Initiative Trust (NDIT) has implemented to allocate funds amongst regions. Director Fisher mentioned that the Northwest Regional Advisory Committee (NWRAC) is still in the process of possibly changing funding allocations for 2<sup>nd</sup> time applicants. The NWRAC funding is currently being oversubscribed. Director Miller noted that it may be difficult for certain projects to be completed with the reduction in funding available. Discussion took place regarding the scoring system utilized by the NWRAC to prioritize applications to move them forward to NDIT.

The Economic Diversification infrastructure funding program applications were discussed. Director Fisher mentioned that his measurable for a project is whether or not the project promotes an RDBN service, would assist in reducing cost to the RDBN, and whether the project has a direct impact to RDBN operations. The importance and the impacts to the region of the Baker Airport were brought forward for discussion. Comments were made regarding the critical need of the Baker Airport and the importance of the Topley Fire Department along with the RDBN support of the Lake Babine Nation application.

The allocation and funding request for the Topley Fire Hall Electoral Area "G" Gas Tax Funds was discussed.

Chair Benedict noted that there are some projects in her Electoral Area that are more urgent and require funding assistance soon.
